- j) Pistol/Small Bore Range: Rule changes were discussed and approved. They are as follows; a) Pistols-rim fire, original centerfire pistol cartridges, black powder and .410 shot shell or smaller. b) Rifles-rim fire and original centerfire pistol cartridges only. c) Shotguns-NOT ALLOWED except for pistols firing shot shell cartridges as listed above. d) Pistol brace/stocks are allowed ONLY if they are pistol caliber. Also new target hangers will be needed.
- k) Rifle Range: A number of high shots have been noticed and investigated. New target hangers will be needed. Public site in dates are Nov. 3<sup>rd</sup>, 10<sup>th</sup> and 17<sup>th</sup>, hours are 9am to 4pm. Liability wavers must be singed.
- 1) Trap/High School Trap: Trap houses have been cleaned. Upper trap thrower had broken belts. New parts have been ordered for repairs.
